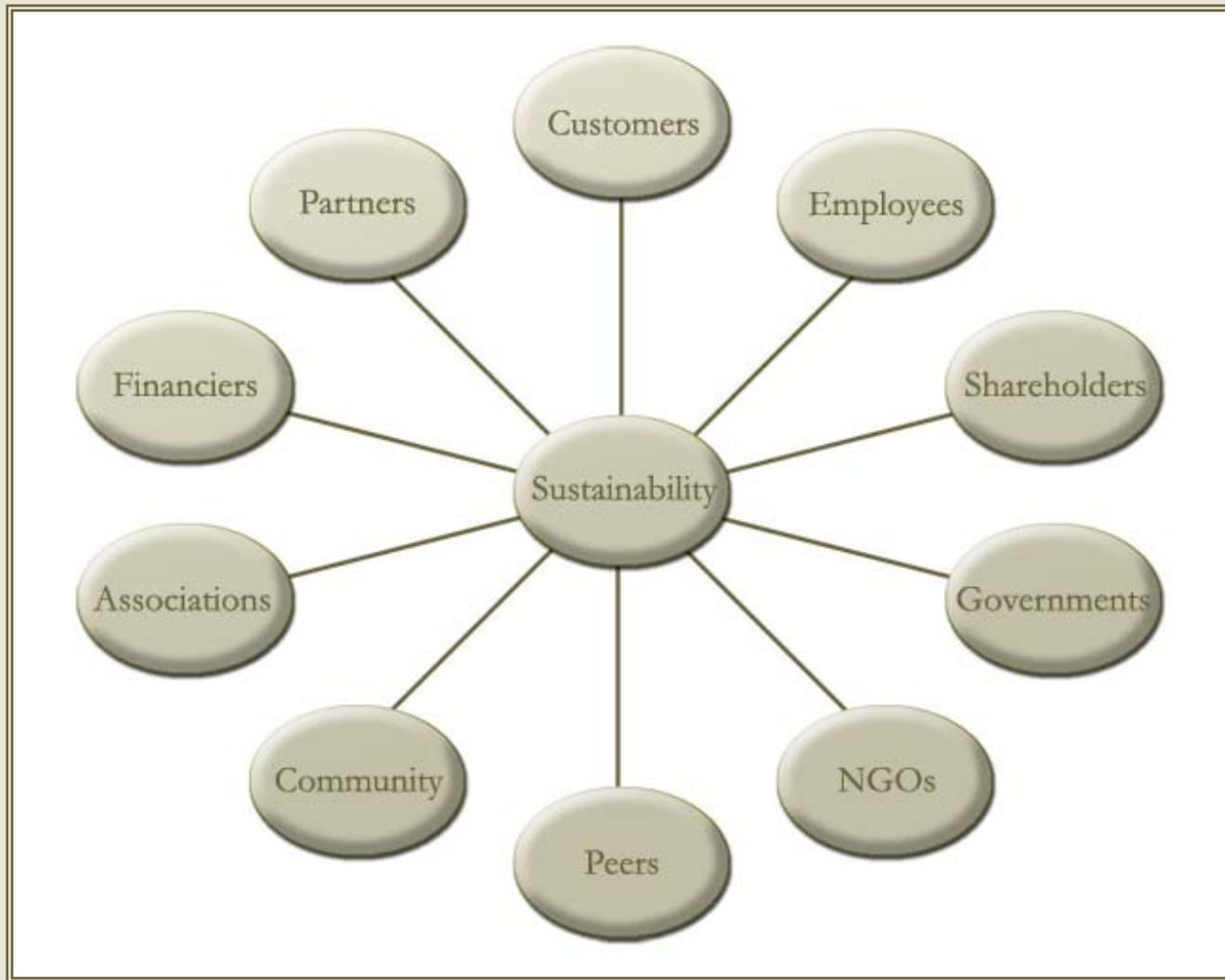
What is CSR or Sustainability?

□ Operational Management

- EHS Program: evaluate the performance of all facilities, strive to identify the root causes of variations in performance and reduce or eliminate these factors

□ Supply Chain Management

- Suppliers must adhere to John Deere Code of Conduct
- Suppliers expected to be familiar with the business practices of their own suppliers and sub-contractors and ensure that they, too, operate within the guidelines of the code

□ Climate Change and Energy

- Working to reduce GHG emission from current operations, designing energy efficiency into facilities, ensuring new facilities minimize them
- Company continues to reduce its product emissions, **which helps customers reduce their GHG emissions**

□ Product Efficiency and Productivity

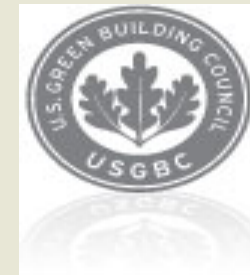
- John Deere incorporates features to lessen environmental impacts or advance sustainable production, efficiency, and safety

- “Green” Governmental Initiatives:
 - Legislation, executive orders, resolutions, ordinances, policies, and incentives are influencing planning, development and renovation of sites
- Currently found across the US:
 - **12** federal agencies or departments
 - **30** states
 - **90** cities
 - **29** counties
 - **20** towns
 - **15** public school jurisdictions
 - **37** institutions of higher education

California Green Building Code

- On July 17, 2008 - California Green Building Standards Code (“Green Building Code”), the first statewide green building regulation of its kind.
- Purpose is to enhance **“the design and construction of buildings through the use of building concepts having a positive environmental impact and encouraging sustainable construction practices.”**

California Green Building Code

- Focuses on improving five key areas of building design and construction:
 - (1) planning and design,
 - (2) energy efficiency,
 - (3) water efficiency and conservation,
 - (4) material conservation and resource efficiency, and
 - (5) environmental air quality.

□ Landscape Relevance

- Section 604.2: Provide water efficient landscape irrigation design that reduces by 50% the use of potable water
- Section 503.1: Nonresidential buildings shall exceed 2007 energy code requirements at least 15%
